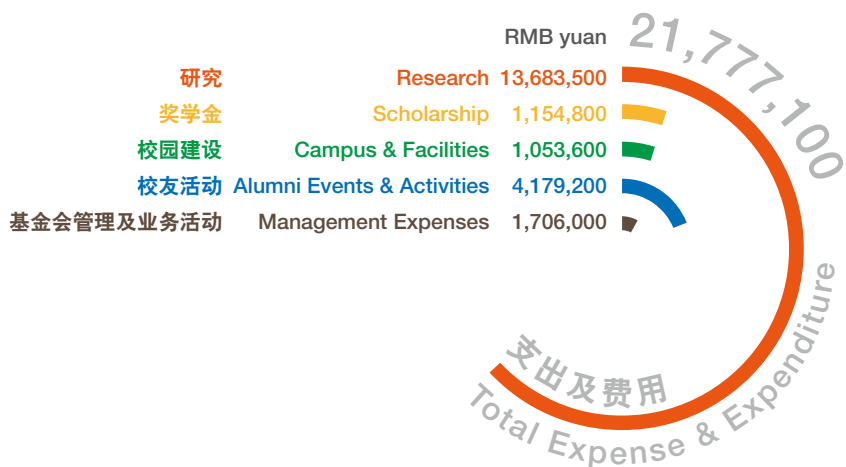
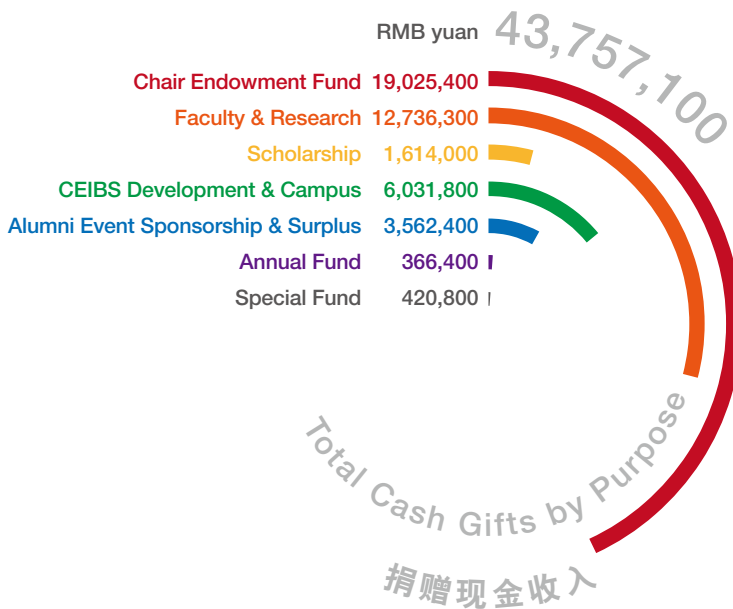
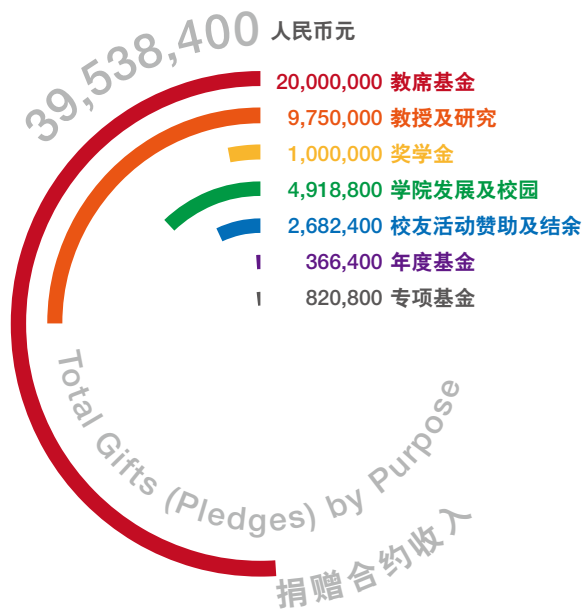

教席基金

延揽全球顶尖的教授

2015年，京东捐赠人民币1000万元，在中欧国际工商学院设立教席。这是中欧得到的第6个由中欧校友企业向学院捐赠的教席。

除了企业捐赠教席外，中欧宝钢经济学教席教授吴敬琏教授宣布设立“吴敬琏经济学教席”。中欧中天集团管理学教席教授朱晓明教授也在2015年设立“朱晓明会计学教席”。

“大学者，非谓有大楼之谓也，有大师之谓也。”中欧国际工商学院拥有一支融汇中西、博学善教、知行合一的世界级教授队伍。5个学科系的近70位全职教授来自10多个国家和地区，拥有丰富的跨国教学、研究和实践经历。最新发布的“2015年中国高被引学者”榜单，在“商业、管理和会计”学术领域中，共有10位（含在任与离任者）中欧教授榜上有名，占该学术领域高被引学者总数的1/3。此外，学院每年还从全球聘请近百位各个领域的访问教授，影响力之强大足以见得。

教席捐赠制度历史悠长，底蕴深远，其魅力在于运用多元社会资源呼唤大师级学者，以助学府永葆创造之源泉、求真之梦想。多年来，得益于捐赠设立的教席，学院已遴选17位享有极高教研成就的教授担任教席教授，支持教席教授开展丰富的课题研究及教学活动。新增的教席基金将继续有效支持中欧的精英师资队伍取得更丰硕的学术成果，从而提高学院在世界范围内的学术地位和竞争实力。





The Chair Endowment Fund

To Recruit and Retain World-Class Faculty

JD.com donated 10 million yuan for a new chair professorship at CEIBS. It is the 6th chair professorship endowed by an alumni enterprise.

CEIBS faculty members endowed two chair professorships: Wu Jinglian Chair in Economics by Prof. Wu Jinglian, CEIBS Baosteel Chair Professor of Economics, and Zhu Xiaoming Chair in Accounting by Prof. Zhu Xiaoming, CEIBS Zhongtian Chair Professor of Management.

“A top university is made not by magnificent buildings, but by great scholars.” CEIBS boasts a world-class faculty team, which is uniquely equipped to deliver a combination of China Depth and Global Breadth in both teaching and research. Nearly 70 full-time faculty members in 5 disciplines represent more than 10 countries and regions worldwide. They bring a wealth of experience from teaching overseas, research and business practice. In 2015, 10 CEIBS faculty members (including outgoing professors) appeared on Elsevier’s List of Most Cited Chinese Researchers in the category of Business, Management and Accounting, making up one third of the total. The School also invites over 100 visiting faculty members each year from all over the world to share and exchange the most up-to-date knowledge from both in and outside China. All these speak volumes about the rising influence of CEIBS.

The long-established chair endowment system is aimed at marshaling social resources to build a distinguished faculty team in relentless pursuit of innovation and excellence. In the past years, CEIBS has successively offered 17 faculty members an endowed chair for their achievements in research and teaching. The newly-established chair endowment funds will inspire CEIBS faculty to step up their research and teaching efforts so as to increase the School’s international stature and competence.

The Scholarship Fund

To Attract Excellent Students

2015 年度英国《金融时报》公布的全球 MBA 百强排行榜上，中欧 MBA 课程名列第 11 位，再度问鼎亚洲商校之首，连续 11 年跻身全球 25 强。MBA 课程当年还获得美国《彭博商业周刊》，美国《福布斯》杂志亚洲第一的位置，使中欧 MBA 课程同时成为世界最重量级商学院 MBA 排名的三料亚洲第一。2015 年底，中欧凭借 MBA 课程 Poets & Quants 商学院报道网站评选为 2016 年全球 10 所最值得关注的商学院之一。中欧也是唯一入主此榜单的亚洲商学院，其他学校包括沃顿、耶鲁管理学院、达顿等世界顶尖商学院。取得如此靓丽的成绩，与中欧奖学金基金捐赠人的无私支持密不可分。

中欧国际工商学院 MBA 课程从办学第一天起，就开始全球招收志向远大、眼界开阔、融合中西方特质、具备国际化视野的青年才俊，并把他们培养成为未来商业领袖。然而站在世界舞台上，与有着深厚历史沉淀和雄厚资本实力的国际名校比肩，中欧也在接受人才的挑选。奖学金基金不仅可以增强学院招生的吸引力，还能缓解优秀学生寒窗苦读的经济压力。对于获奖学生而言，奖学金的意义不仅是物质上的奖励，更是人格上的教育。学生在获得奖励的同时，增强了社会认同度、学校荣誉感，树立了责任之心、公益之心。

In 2015, CEIBS MBA Programme moved up to #11 in the FT's ranking of global business schools, maintaining its lead in Asia and ranking among the world's top 25 for 11 consecutive years. The programme was also ranked #1 in Asia by *Bloomberg Businessweek* and *Forbes*. At the end of 2015, by virtue of its MBA programme, CEIBS became the only Asian business school to make it to the Poets & Quants' list of "Ten Business Schools to Watch in 2016". The other business schools included big names such as Wharton, Darden and Yale School of Management. The School's shining performance is credited to scholarship fund donors.

Since the inception of CEIBS MBA Programme, we have been dedicated to enrolling talented, ambitious and globally-attuned youngsters, and grooming them as future business leaders. These promising candidates are also benchmarking CEIBS against other world-renowned business schools, which boast a profound history and solid financial strength. The scholarship funds can help expand our pool of candidates, alleviating the financial burden of students. The scholarships, which mean more than a material award, can instil recipients with social responsibility and public welfare as well as a sense of pride in the school.

2015年10月20日，“中欧—诺亚滴水泉项目”诞生。该项目由中欧主导发起，并联合校友企业诺亚财富集团及旗下互联网金融子公司财富派共同实施。它开创性地将金融工具与互联网技术相结合，搭建校友捐赠-助学贷款平台，以校友捐赠或出借的资金为基础，向符合条件的中欧MBA学生提供低息助学贷款。使中欧在现有奖学金基础上，将财务资助惠及所有MBA学生。

On October 20, 2015, the CEIBS-Noah Di Shui Quan Project was launched. Initiated by CEIBS and implemented together with the CEIBS alumni company Noah Holdings Ltd. and the subsidiary Cai Fu Pai, the Project has made CEIBS the first ever business school to combine financial instruments and Internet technology to grant eligible MBA students low-interest loans based on alumni donations or lending. As a supplement to the School's Scholarship Fund, the Project will provide all MBA students with access to financial subsidies.

研究基金

研究学术前沿的课题

持续的知识传播需要以雄厚的研发实力作为坚实后盾。中欧国际工商学院的学术研究成果卓著，后劲强悍。2011-2015年，中欧教授在英国《金融时报》45种学术期刊以及A*学术期刊上发表论文多达127篇。自2001年起，中欧开始建立一系列研究中心，以集中力量在学院确认的重点领域展开研究。至今，中欧已成立了案例研究中心、中欧陆家嘴国际金融研究院、中国企业全球化研究中心、中欧家族传承研究中心、上海数字化与互联网金融研究中心等21个研究中心及机构，形成了学院学术研究的稳固架构。学院每年开发100多个中国本土案例用于中欧课堂，承建“中国工商管理国际案例库”，已收录近800个中国主题案例。

正是中欧研究基金捐赠校友和企业支持着学院延续创新精神。他们鼎力资助中欧教授为商业之道推陈出新，为中国和世界的管理实践和知识开发牵线搭桥。

First-rate academic research lays a solid foundation for continuous knowledge dissemination. CEIBS will build on the academic achievements that have captured worldwide attention. From 2011 to 2015, CEIBS faculty members published a total of 127 papers on the British FT45 and A* academic journals. Since 2001, CEIBS has established research centers and institutes to step up research on key areas. Presently, 21 research centers and institutes, such as the Case Development Center, CEIBS Lujiazui Institute of International Finance, Center for Globalization of Chinese Companies, CEIBS Center for Family Heritage, and Shanghai Institute of Digitalization and Internet Finance, have laid groundwork for the School's academic research. Each year, CEIBS faculty members prepare more than 100 China-focused cases for class teaching. Initiated by CEIBS, The Global Platform of China Cases has incorporated over 800 China-focused cases.

It is the donations made by CEIBS alumni and companies to the Research Fund that have inspired CEIBS faculty to break new ground in research so as to facilitate management practice and knowledge creation in China and the world at large.

2015年2月3日，九阳股份有限公司董事长王旭宁校友(EMBA2001, CEO2010)向中欧捐赠人民币200万元设立“中欧—九阳研究基金”，支持互联网环境下传统企业转型等相关课题。在“中欧——九阳研究基金”的支持下，“中国制造企业平台转型过程研究”、“组织设计与激励对于企业内部创新创业的影响机理”、“互联网+背景下供应链合作创新及产业转型升级研究”三个课题已进入研究阶段。

On February 3, 2015, Joyoung Chairman Wang Xuning (EMBA2001; CEO2010) donated 2 million yuan to CEIBS to establish the CEIBS-Joyoung Research Fund for research on the transition of traditional companies in the Internet age. Currently, research projects under way include “Research on the Platform Transition of China's Manufacturing Sector”, “Influence of Organizational Design and Motivation on Startup and Innovation within the Company”, and “Research on the Supply Chain Cooperation and Innovation, and Industrial Upgrade and Transition against the Backdrop of Internet Plus”.

To Conduct Leading-edge Research



On August 28, 2015, Cathay Capital Chairman Cai Mingpo (EMBA2004 and CEO2009) donated EURO 500,000 to CEIBS to establish the “CEIBS-Cathay Capital Global PE Research Fund”, which aims to promote global PE investment and innovation. So far, three research projects are under way: “Integration and Motivation for Overseas Subsidiaries: The Practice of Shang Gong Group”, “Role of Venture Capital Funds: To Improve Corporate Governance or Acquire Relationship Resources” and “Influence of PE Funds on Strategy and Performance of the Company Invested”.

陆家嘴金融研究院

2015年，中欧陆家嘴国际金融研究院积极响应十八届三中全会关于建设新型智库的要求，围绕与金融改革和上海国际金融中心相关的前沿课题开展研究与交流，包括金融促进科技创新中心、互联网银行、设立上海金融法院、IPO注册制改革、金融业营改增、自贸区资金池、土地财政、刚性兑付、云南泛亚交易所事件等。研究院与财新传媒、匈牙利央行、上海市金融消费纠纷调解中心等合作举办学术论坛，在财新网开设“陆家嘴沙龙”专栏，不断扩大社会影响力。

CEIBS Lujiazui Institute of International Finance

In response to the call for establishment of new think-tanks issued at the Third Plenary Session of the 18th CPC Central Committee, CEIBS Lujiazui Institute of International Finance (CLIF) conducted academic research and exchange in 2015 on how to promote China's financial reform and develop Shanghai into an international financial center. The research topics included the contribution of the financial industry to the S&T innovation center, Internet banking, establishment of a financial court in Shanghai, registration-based IPO system, replacement of the business tax with a value-added tax in the financial industry, cash pooling for China (Shanghai) Pilot Free Trade Zone, land revenue, rigid payment, and Fanya Metal Exchange scam. CLIF hosted academic forums, in partner with Caixin Media, Hungarian National Bank, and Shanghai Municipal Financial Consumption Dispute Mediation Center, and launched the "Lujiazui Salon" column at caixin.com to expand its influence.

跨境电商研究中心

2015年9月22日，中欧·上海跨境电子商务研究中心正式成立。成立后的研究中心积极响应《国务院关于积极推进“互联网+”行动的指导意见》，为跨境电商和监管部门提供一流的研究和咨询服务。争取推动、引领跨境电商健康、规范发展，使之成为未来国际贸易转型的切入点和突破口。研究中心开展“2015中国（上海）互联网+外贸高峰论坛”，直面企业在转型升级中遇到的难点与痛点，助力电商企业合作与发展。12月受上海青浦出口加工区开发有限公司委托，就青浦区及青浦出口加工区发展科技创新与跨境电子商务产业提供咨询报告。

CEIBS-Shanghai Research Center of Cross Border E-Commerce

On September 22, 2015, the CEIBS-Shanghai Research Center of Cross-Border E-Commerce was founded. In accordance with the Proposals of the State Council on Pushing Forward the "Internet Plus" Program, the Center is committed to providing cross-border e-commerce companies and regulators with first-rate research and consulting service so that the healthy development of the cross-border e-commerce industry can pave the way for international trade transition. The Center hosted "2015 China (Shanghai) Internet + Foreign Trade Summit Forum", where guests shared their insights into cooperation between e-commerce companies and the pain points in transition. In December 2015, the Center was commissioned by Shanghai Qingpu Export Processing Zone Development Co., Ltd. to prepare a consulting report on technological innovation and cross-border e-commerce industry in Qingpu Export Processing Zone and Qingpu District at large.



上海数字化与互联网金融研究中心

2015年，中欧—上海数字化与互联网金融研究中心在朱晓明教授的领导下，研究成果颇丰，社会及学术影响力不断扩大。15年初，研究中心参与金融智库英凡研究院的建立，该研究院由第一财经和蚂蚁金服发起，由中国人民银行金融研究所、上海市金融办、北京市金融局联合战略支持建立，并提出了《英凡研究院学术研究领域及前沿科技创新建议案》。6月，朱晓明教授出席陆家嘴金融论坛发表主题演讲《金融创新，切莫错失科技创新》。同时，研究中心参与工商银行在杭州举办的“银行互联网之路”主题峰会，应中国工商银行董事长姜建清的邀请，朱晓明教授出席活动并做主题演讲和圆桌讨论，以2016年即将发布的《商业趋势与科技创新案例集》为导读为在座金融机构及各界行业领袖讲述了研究中心最新数字化与互联网金融的案例。

中欧家族传承研究中心

中欧家族传承研究中心2015年继续主办了年度家族企业论坛，并以每季度深入不同区域的家族企业的方式，分别在宁波、深圳、苏州等地进行了圆桌研讨会或私人董事会。发布年度白皮书报告《治财有道——中国民营企业家族财富管理》，并在哈佛商业评论、福布斯中文版、清华管理评论、接力杂志、家族企业杂志等多家媒体发表文章11篇。中心秉持着对于成为领先的家族企业学术研究机构追求，创造、分享家族企业在新兴市场的相关资源及知识，并为东西方家族企业提供交流平台。

Shanghai Institute of Digitalization and Internet Finance

With Prof. Zhu Xiaoming serving as Director, the CEIBS-Shanghai Institute of Digitalization and Internet Finance (IDIF) scored considerable achievements, demonstrating a growing academic reputation. In early 2015, IDIF participated in the establishment of the Internet Finance Institute, a financial think-tank that was initiated by CBN and Ant Financial, and co-founded by the Financial Research Institute of the People's Bank of China, Shanghai Municipal Financial Service Office, and Beijing Bureau of Financial Work, and put forward the Proposal on the Academic Research and Cutting-edge Technological Innovation of Financial Research Institute. In June, Prof. Zhu Xiaoming delivered a keynote speech entitled "Technological Innovation: Indispensable for Financial Innovation" at the Lujiazui Forum. In addition, at the invitation of ICBC Chairman Jiang Jianqing, Prof. Zhu Xiaoming delivered a keynote speech and entered into roundtable discussions at the "Bank's Path to Internet Finance" Summit organized by ICBC in Hangzhou. By citing the *Selected Cases of Business Trends and Technological Innovation* to be published in 2016, he shared with the representatives of financial institutions and industrial leaders the latest cases concerning digitalization and Internet finance.

CEIBS Center for Family Heritage

In 2015, the CEIBS Center for Family Heritage (CEIBS CFH) continued to host the Annual Family Heritage Forum, and convened roundtables or private board meetings in Ningbo, Shenzhen and Suzhou on a quarterly basis. CEIBS CFH released its annual White Paper Report "Wealth Management of the Chinese Private Family Business", and published 11 articles in Harvard Business Review, Forbes China, Tsinghua Business Review, Fortune Generation, and China Family Business Review. CEIBS CFH is devoted to becoming a leading family business research institute to create and share resources and knowledge concerning family firms in emerging markets, and to provide Eastern and Western family businesses with a platform for exchange.
